Flea Market Rules and Regulations

In order to participate in the Flea Market your completed registration form and rental fee of \$20.00 must be received in the market management office no later than November 10, 2009.

Registration form is located on 2nd page of this flyer or can be picked up in the market management office is located in the hallway near the restrooms.

Flea Market participant check-in is from 7:30 am to 8:00 am.
Only used household items, clothing, small furniture and toys are allowed to be sold.

DO NOT BLOCK DRIVEWAY AT ANYTIME DURING UNLOADING, LOADING OR SALE.
Vehicles must be moved after unloading to back area designated by management.

You will be given a number for a designated space at time of check in and you must use only that space for your items.

Rented space must be kept clean, neat and organized; you must bring your own display items.
Canopies may be used but must be weighted with buckets of sand or weights.

All items must be removed no later than 5:00 pm the day of the event. No items may be placed in the Market dumpsters or trash cans. If you bring it you must take it away.

Market Staff has the right to refuse items deemed not family appropriate and those items must be removed from your space when notified.
