PURPOSE & BACKGROUND

- Housing & Neighborhood Preservation (DHNP) is accepting public comments on its proposed 2017 – 2018 Annual Action Plan (AAP)
- This plan is required by the U.S. Department of Housing and Urban Development (HUD)
- The public comment period is from April 7 – May 6, 2017

DRAFT 2017 – 2018 ANNUAL ACTION PLAN (AAP)

- Outlines how the city will use and allocate funding under the following federal entitlement grants during the next fiscal year (July 1, 2017 – June 30, 2018):
 - Community Development Block Grant (CDBG)
 - Home Investment Partnerships (HOME)
 - Emergency Solutions Grant (ESG)
 - Housing Opportunities for People with AIDS (HOWPA)
- Management tool for assessing performance and tracking results
- Provides summary of the city's housing and community development needs, resources, and strategies

DRAFT 2017 – 2018 ANNUAL ACTION PLAN (AAP)

Our overall mission for the use of Federal funds is to expand affordable housing opportunities and promote vibrant, well-maintained neighborhoods. Part of this strategy is to make homelessness rare, brief and non-recurring. We work within the direction of the City Council and the city manager to help continue and enhance Virginia Beach as a great place for all life stages.
