Topic: Fee changes for Building Permits, & Planning Commission/City Council, Board of Zoning Appeals, Wetlands Board, Chesapeake Bay Preservation Area Board (CBPA) Applications

Effective July 1, 2018

On May 15, 2018 City Council, as part of the FY19 Resource Management Plan, approved fee changes associated with building permits, building plan review and various board/commission applications.

Building Permits and Building Plan Review Fees

The Virginia Uniform Statewide Building Code Section 107 allows a locality to assess fees to defray their costs of associated code enforcement. Therefore, effective July 1, 2018, the following plan review and permit fees may be applicable to your project.
