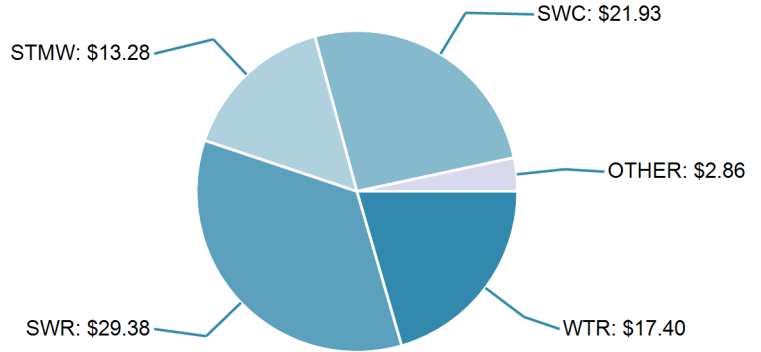

ABOUT OUR SERVICES



Solid Waste Collection - Billed as a fixed daily charge, this service covers the costs of collecting, handling, and disposing of trash and recycling.



Storm Water - Billed as a fixed daily charge, this fee offsets the costs for maintaining and upgrading drainage facilities.



Sanitary Sewer - Billed as a fixed daily charge, this service offsets the costs for operating and maintaining the sanitary sewer system, and for transporting sewage to Hampton Roads Sanitation District (HRSD).

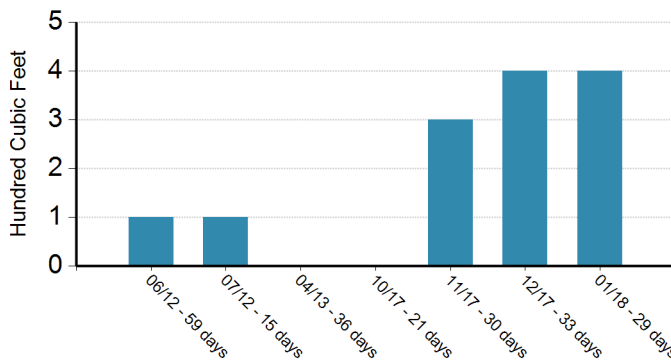


Water - Based on water usage, this charge covers the cost of treating and delivering clean water.

Service Availability - Billed as a fixed daily charge, this fee helps defray costs associated with maintaining and reading your meter, as well as billing and related costs.

Utility Tax - This tax is imposed on all utilities by the City of Virginia Beach at a rate of 20%, or a maximum of \$3.00 per month, on residential services.
